# Omaha Quilter's Guild Board Meeting February 7, 2023

President Tania Uram called the meeting to order at 7:02 p.m.

October board minutes: Tania asked for additions or corrections to the minutes. Nancy made a motion to approve the minutes as written. Yvonne seconded the motion. All approved.

October treasurer's report: Janelle handed out the treasurer's report. Tania asked for additions or corrections. Liz made a motion to approve the report as written. Angella seconded the motion. All approved.

### Treasurer - Janelle Reed

Janelle reported that the current balance is \$70,237.10. Our 18 month CD will be renewing. The interest rate will go from .65 percent to 4.52 percent. Janelle also informed the board that she has paid the insurance renewal, the advance deposit for the quilt show to Embassy Suites, and taxes, in the amount of \$1,235.37, for the quilt show.

### President - Tania Uram

Tania informed the board that she received two copies of "Quilt Folk" magazine and a calendar. One copy of the magazine will go in the library and the other 2 items will go to membership for door prizes. Tania also signed up to promote the guild with quilts and information in a display case at Millard Public Library next August. Carol Nish will be helping her with the display case.

Eilene reported that after the nominating committee met, she has been contacting members to ask them about serving in the open positions on the board. Positions that remain open are: Recording Secretary, Newsletter, Quilt Show Chairman, Bus Trip, Rising Stars, and Quilt Mom. Zantean Dean volunteered to take the Rising Stars position.

# Programs - Eilene Hengen/Yvonne Wilson

Yvonne reported that she is working on the remaining contracts for 23/24. As soon as she has finalized those contracts, she will work on 24/25. Some discussion was held on when to have the boards with the workshop/speaker information available at the guild meetings. It was suggested that they be ready before the end of the year. Eilene reported that the remaining workshops for this year are full except for May. There are one or two spots remaining in May.

Patty informed the board that she will have a handout available at the meeting which will include information for members who joined after the directory was published. She will also provide a new online file for Amy to publish. Dues for next year will be accepted at the quilt show or later.

Camp will be held October 19-22, 2023 and October 3-6, 2024. An extra, optional day has been added on Thursday for those quilters who would like a longer stay.

Golden Thimble - Nancy Wells, Nancy Peters, Windy Benigno Nancy Wells reported that the committee will be asking for nominations in the coming months.

# Helping Hands - Angie Reed

Angie reported that she delivered 145 Christmas stockings and 145 pillowcases to Project Harmony on December 19, 2022. On January 25, 2023, she delivered 14 baby kits, 9 adult kits and 10 toddler kits to the Omaha Home for Boys. She also delivered 100 pillowcases on February 1, 2023 to the Least of My Brethren. Angie reported that they use 10 pillowcases per week and she will continue to help supply them with pillowcases. Angie then informed the board that some guild members have been asking her if they could have a second sew-in for Helping Hands in January. Angie proposed that she pay the room fee to Westside out of her budget. After some discussion, it was decided that since the guild voted to move the January meeting to August, it must be clear to members that this is not a guild meeting. It was decided that Angie is free to invite members to come and sew at this Helping Hands event. It will not be called a "Sew-In" so members won't confuse this event with the guild meeting in August.
